Community Investment

Why is Community Investment important?

Community Investment through a tax-deductible gift to Tempe Prep allows us to *maintain small class sizes* and *low teacher-to-student ratios*. Much of our success is due to the smaller number of students in each class, which aids teachers in getting to know your child and how to best help him/her in the learning process.

Your tax-deductible gift also allows us to *attract and reward excellent teachers* who are so important to our school's continued success.

Your support of the Community Investment campaign will help bolster TPA's operating budget and provide us with added funds to be used where we need them most—in the classroom.

Participation in Community Investment:

Tempe Preparatory Academy asks that each family contribute \$1,200 per student per year to help us close the gap between what we need to educate your children the way we do and the public funds we receive to do so.

We appreciate gifts of any size and hope that 100% of families will participate in this campaign as they are able.

This request is not an easy one, but your *participation in this campaign demonstrates the value you place on an excellent education for your children*.

Tax Credit

What is the Tax Credit Drive?

The Arizona tax credit program is a way for Arizona taxpayers to direct a portion of their state taxes to Tempe Preparatory Academy to be used to support qualifying extracurricular activities and character-building programs.

Married taxpayers who file jointly can contribute up to \$400 and single filers can contribute up to \$200 and receive a full credit for the amount on their state tax liability.

In other words, those who contribute a tax credit to Tempe Prep receive a **dollar-for-dollar credit** against the taxes they owe to the state!

Who can Participate?

Anyone who pays Arizona State taxes is eligible to participate in this program and donate to Tempe Preparatory Academy. Because this is ultimately a no-cost donation to the school, we ask that 100% of our TPA families participate in this program.

In addition, we ask that families reach out to their relatives, neighbors, friends, and co-workers to support our extraordinary school.
